Decision to grant a license to exercise the inspection issuing a certificate of conformity in the country of origin/ source of goods supplied to Iraq

In accordance with the provisions of the articles (second item first /3), (second hand seventh/7) and (fourth/ general provisions of the numbered contract/1) from the numbered contract (10) in 20/11/2019 that grants a license to exercise the inspection issuing a certificate of conformity in the country of origin / source of goods supplied to Iraq , origin Based on your company's fulfillment of the requirements for issuing the licensing decision, it was decided to grant you an inspection license to issue a certificate of conformity in the country of the exporting consultant for the goods supplied to Iraq for a period of (3) three years starting from the date of 1/3/2020.

Your company is required of:

- 1- All the provisions of the contract for granting a license to inspectors to issue a certificate of conformity in the country of origin to export goods supplied to Iraq.
- 2- All the texts and provisions in the contract in the terms of application, interpretations and settlement of conflicts to the laws of the Republic of Iraq and the jurisdiction of Iraq judiciary.
- 3-The performance of the company is subject to continuous evaluation by the device and adherence to the directions issued by it.
- 4-The company is obliged to meet the fixed fees to issue conformity certificates (in the country of origin) and to inspect the boarder outlets according to what is stated in Article (second/ seventh item/ 7).
